# TERMS AND CONDITIONS FOR SUPPLY OF INDUSTRIAL GASES IN CYLINDERS BELONGING TO THE COMPANY

### **CYLINDERS**

Gases are supplied in cylinders, which are given on loan against cash security deposit at the prescribed rate. The cylinders are to be returned to the company immediately after the gas is used. Cylinders are not transferable and resale of its contents without the written consent of the Company is prohibited. The Company may refuse to supply gas to any Customer who may have transferred Cylinders belonging to the Company and reserve the right to take legal action for breach of agreement. Cylinders are not allowed to handover or transact with any seller without prior approval of LINDE. After completion of the job same cylinder to be returned to LINDE.

#### CYLINDER DEPOSIT

Customers are requested to make a deposit for cylinders issued to them at the prevailing rate. It is to be noted that the deposit rate per cylinder does not cover the full cost of a cylinder & this rate is subject to change at any time without prior notice. If the company enhances the rate of security deposit customer will have to deposit the difference amount.

# **REFUND OF CYLINDER DEPOSIT**

Cylinders deposit are refunded on return of the cylinder in good condition, payment of all dues and surrender of the original Cylinder Deposit Receipt (CDR)

Cylinder deposit refund is made by Account Payee Cheque in favour of the account name.

#### **CYLINDER RENTALS**

Currently there is no free loan period for industrial gases cylinder and 15% Vat applicable on rent. Any change in rental & vat rate which will applicable for all customers with effective date .Rental rate is subject to change at any time without prior notice.

For keeping cylinders, cylinders rentals will be charged as per below mentioned table until further review.

Facilities are available at the sales counter for customers to check pressure and condition of the cylinder while taking delivery. After the cylinder has been taken out of the sales premises, the company may not entertain any claim.

# **USE OF CYLINDER**

If any cylinder is damaged or been found damaged the cylinders should immediately be brought to the company for the necessary repairs. It is strictly prohibited for customers to try to rectify / repair the defect. However, in doing so if any accident occurs, the responsibility, of the accident will be on the customer. Customers are responsible for the safe custody and proper use of cylinders.

At present Loss or damage to cylinders, any of its fittings or excessive loss of DMF are recoverable by the Company at the following rates; This rate is subject to change at any time without prior notice: Please note that, following rates are subjected to 15% VAT.

#### **CUSTOMER IDENTITY CARD**
