

Emergency Medical Oxygen Set for Domestic use on Rental Scheme

Rental Scheme:

Medical Oxygen is treated as an essential and emergency life saving Drug. In order to meet the emergency situation of any individual a rental scheme is in operation by **Linde Bangladesh Limited** to provide essential Medical Oxygen.

Rental Set:

Emergency Rental set means a complete Medical Oxygen delivery system comprise of followings:

- One Medical Oxygen Cylinder (Size 1.40 Steel)
- One Oxy therapy set (Flow meter and a Regulator)
- One Cylinder carrying trolley.

However the set does not include Compressed Medical Oxygen, facemask and humidifier, which the customer will have to make outright purchase.

Entitlement:

This scheme is designed to operate only to handle the emergency situation by any individual. Under no circumstance this scheme will be applicable to any **CLINICS**, **HOSPITALS**, **MEDICAL DISPENSARIES**, **PRIVATE PRACTITIONERS**, or any commercial use. Patients who are attending or under treatment in Clinics, Hospital etc are not eligible for this Scheme.

Period of Supply:

This rental scheme is applicable only for handling emergency use. Scheme user is requested to return the Cylinder along with the set within 30 days from the date of taking the delivery. In case of any further need the set can be reissued, but under no circumstance the customer can retain the cylinder for more than 30 days.

Supply:

Supply will be made on deposit of Tk. **25,000.00** (Taka Twenty Five Thousand) as security deposit. If the delivery is taken within the Office hour an invoice will be generated along with the Deposit voucher for Security deposit, otherwise the Customer will have to collect the invoice on the next working days.

Rate and Rental:

Following rates are applicable:

From day one Taka 29/- per day, per cylinder rent is applicable.

Terms and Conditions for Rental

- 2. I confirm that the above patient has been recommended or prescribed by a Registered Physician.
- 3. I confirm that this set shall be used only for the emergency purpose only.
- 4. I, confirm the above Rate of Rentals and Rate of Consumables.
- 5. I, confirm that I shall return the complete set to Linde Bangladesh Ltd at their Sales counter within 30 days from the date of taking delivery. If I fail to return the set within the period, LINDE has the right to:
 - a. Compel me to purchase the set at a price to be fixed by LINDE BANGLADESH LTD.,
 - b. Refuse to re-fill the cylinder,
 - c. Ask for the return of the cylinder to LINDE BANGLADESH LTD. which I shall comply with immediately,
 - d. Immediately take into LINDE BANGLADESH LTD.'s custody the possession of the set from me,
 - e. Can also allow extension of rental period beyond 30 days
 - f. Adjust my security deposit with the price of cylinder set.
- 6. The ownership of the legal title of the full set comprising of Ox therapy set, cylinder and trolley shall always remain with LINDE BANGLADESH LTD..
- 7. I, confirm that I shall not transfer or lease or sublet the cylinder to others.
- 8. In case of any loss or damage to the set, I shall bear the cost of the set or pay for the damage components at the rate fixed by the LINDE BANGLADESH LTD..
- 9. I shall clear all outstanding dues/rents at the time of each re-filling of the cylinder, failing which LINDE BANGLADESH LTD. will have the right to refuse supply and immediately take possession of the full set.
- 10. I shall use this set as per the instruction of LINDE BANGLADESH LTD. and shall take full responsibility for proper and correct use of the set and I confirm that LINDE BANGLADESH LTD. will have no liability whatsoever, in the event of any accident or damage or loss or other dues.
- 11. I shall deposit Tk. 25,000.00 (Taka twenty five thousand only) as a Security deposit which will be refunded when the set is returned to LINDE BANGLADESH LTD., subject to adjustment of any outstanding rent or cost for damage or loss or other dues. I do agree with the mode of payment as mentioned by LINDE BANGLADESH LTD. as either Account Payee Cheque or Cash Cheque but no cash payment for refund.

If I am failed to return the cylinder and close this emergency scheme within 6(six) months to LINDE BANGLADESH LTD., than LINDE BANGLADESH LTD. will have the right to adjust the price of the Emergency Set (including cylinder & accessories) and any other outstanding with the security deposit on any next working day after six months. By this, I am indemnifying LINDE BANGLADESH LTD. to adjust the security deposit amount with the emergency cylinder set. LINDE BANGLADESH LTD. does not need to maintain any correspondence with me to settle the issue.
